- The bidder should necessarily be registered with Income Tax and Sales Tax Departments (both) (copy of relevant documents may be produced).
- The rates quoted must remain valid for a period of **60 days** after opening of bids.
- The tender documents must be accompanied with returnable earnest money @2% of the total quoted value of the articles in the shape of call deposit in favour of Director General, Bureau of Statistics Punjab. Incomplete and conditional tenders will not be considered.
- The Sealed Tenders/Bids should be dropped in the Tender Box kept at the office of the undersigned latest by **29-01-2015 at 11:00 A.M.** which will be opened on the same day at **11:30 A.M.** in the presence of tenderers or their authorized representatives.
