SUBJECT:- BID EVALUATION RESULT OF TENDER ENQUIRY DATED 12.11.2014

The Sealed Bids based on item wise rates for the purchase of Office/IT equipment for the Bureau's schemes titled "Strengthening of IT infrastructure and Development of Online Databases for Bureau of Statistics (BoS) Punjab" and "Construction of Office Building of Bureau of Statistics, Headquarters Office, Lahore" for the Financial Year 2014-15 were invited in accordance with the single stage two envelop procedure laid down in Rule-38(2-a) of Punjab Procurement Rules 2014. The tender notice inviting bids was got advertised on PPRA's & Bureau's website as well as in two national daily Newspapers on 22.10.2014. The last date of receipt of bids was 12.11.2014 (11:00 am). The bids received were opened publically in the presence of bidders on the fix date i.e. 12.11.2014 (11:30 am). The list of participated bidders is as under:-

The Meeting of Technical/Purchase Committee was held on 12.11.2014 to open the bids, evaluate responsiveness and finalize the bidders. M/S Ahmad Traders, Hoscombe Business Solutions & O&A Business failed to submit the tender in the manner prescribed under tender notice inviting bids. Therefore the committee decided to ignore their tenders. The representative of the said firms were present at that time thus informed at the spot accordingly. The responsiveness of bids received was finalized on the basis of evaluation criteria/required specifications given in the bidding documents. The detail of bidders who participated as against each item and list of bidders declared technically responsive is as under:-



Initially, the result of technical evaluation of bids was announced publically in the Financial Evaluation Committee meeting held on 18.11.2014 at 11:30 am in the presence of bidders. The technically responsive / cleared / accepted bidders were evaluated. The envelopes marked as "Financial Proposals" submitted by M/S Delite Appliances, Nasco Traders & Office Wares were returned un-opened to the representatives of bidding firms as the same was not technically responsive.

Secondly, in pursuance of Rule 38(2-a)vi PPR-2014 the financial proposals submitted by technically qualified bidders were opened publically and unit price and bid amounts quoted by bidder were announced in the presence of all bidders. The result sheet / Financial Comparative Statement showing status of each item and bidder with regard to financial evaluation is given below:-

M/S Office Automation Group appeared as only complying bidder against copy printer/digital duplicator but their quoted price was on higher side significantly keeping in view of the budgetary estimates therefore the firm was asked for reduction of price. The firm accordingly revised their price and reduced at Rs.349,000/-. The same was accepted by the committee. The Committee rejected the proposals against the items mentioned against Sr. No. 2 & 6 of the above table under Rule 35 of the Punjab Procurement Rules 2014. The bids of M/S COS traders mentioned against Sr. No.3, 4 and 5 were considered lowest evaluated bids thus accepted. Whereas, the bid of M/S Wooden Furniture Common Facility Centre, PSIC, Chiniot against all the furniture items was accepted except the item "Work stations for IT Lab". The bid against the Item "Work stations for IT Lab" was rejected under Rule 35 of the Punjab Procurement Rules 2014.
